







Missing Link Network Rules and Bylaws

- 1. Membership is a minimum 1-year commitment
- 2. Each member of the group will be the sole representative of a given profession.
- 3. Each member must be engaged in that profession as their main business and hold a current business license.
- 4. More than one member of a profession may be allowed in if the parties are engaged in different aspects of the profession that do not conflict, in the view of the Membership Committee. Thereafter, the decision to offer membership to the second party is at the discretion of the membership committee and the current member.
- 5. All members of the group must be of good moral character and must follow the written Rules and Bylaws of the group.
- 6. No member of the group will act in any manner which undermines or conflicts with the profession of another member.
- 7. No member shall be a member of any other referral group of this kind.

Dues

- 1. Dues are \$400 annually for each year, or \$125 per quarter with 1 year commitment recurring auto-pay agreement.
- 2. Dues are non-refundable.
- 3. Missing Link Network reserves the right to increase dues at any time.

Attendance

- 1. Members are allowed no more than four absences of weekly meetings and quarterly mixers in any 6-month period.
- 2. Members can miss no more than three meetings in a row
- 3. If a member is unable to attend a meeting, that member may have a substitute attend who are not a current member of the group. Members who procure a substitute will not be charged with an absence.
- 4. Members are expected to be on time.
- 5. It is the members' responsibility to be aware of scheduling for meetings and quarterly mixers, and any changes that might occur due to unforeseen circumstances.









Minimum Standards

1. Members' activity will be based on a point system. Links must have 100 points to keep their seat.

Leadership

1. Hub Organizer

- a. 3-year Term
- b. Leads the and organizes the Hub
- c. Maintain speaker calendar for the Hub
- d. Liaison between Missing Link Network and the Hub
- e. Works with membership, events and social media leaders to better the Hub.
- f. Membership committee representatives

2. Membership Lead

- a. 1 year commitment
- b. Welcome and educate guests on the benefits of joining Missing Link Network
- c. Organize campaigns and incentives for Hub growth
- d. Work with Hub Organizer and Social Media lead to grow the Hub
- e. Membership committee representatives

3. Social Media Lead

- a. 1 year commitment
- b. Help maintain the social media presence of the Hub
- c. Organize social media drives for the Hub
- d. Promote Hub and events on social media platforms
- e. Work with other leadership to grow the Hub
- f. Membership committee representatives

4. Hub Accountability Lead

- a. 1 year commitment
- b. Keep record of Hub attendance
- c. Keep track of points
- d. Work with other leadership to incentivize Links and grow the Hub
- e. Schedule and track speaker rotation.
- f. Fundraising for Hub events (50/50 raffle)
- g. Membership committee representatives









Membership Committee

- 1. The Membership Committee shall qualify new applicants before voting as to their admission.
- 2. Any membership disputes shall be brought to the Membership Committee for resolution by a majority vote of the Committee.
- 3. The Membership Committee shall review each member every 6 months and make a recommendation to the general membership as to that member's continuation in the group. This review will be based on a member's absences, and points accrued.

Failure to adhere to the bylaws is grounds for dismissal. The undersigned agrees to all Rules and Bylaws and expressly consents to releasing and holding harmless Missing Link Network, Hub, its members, designees, sponsors and other participants from any loss or damage to business, reputation, property or person, arising out of participation in the group.
