# Missing Link Network Rules and Regulations

- 1. I/We, the applicant, hereinafter referred to as the "Member" or "Members" hereby apply for Membership in the Missing Link Network LLC (hereinafter referred to as "MLN") for the purpose of connecting with other business professionals using the MLN system.
- 2. I/We agree to read and abide by the rules and regulations prescribed below which are incorporated with and made a part of this agreement and further agree that this agreement may be amended from time to time in the manner provided herein.
- 3. MLN may freeze a member's account and/or cancel this agreement if:
  - a. MLN has received two or more complaints on a given Member for either poor performance or dishonest business practices
  - b. The Member has committed fraud against MLN or any MLN Members
  - c. For any other reasonable cause.
- Member agrees and acknowledges that the decision of MLN to freeze and/or terminate the Member's account shall be final and conclusive and in the sole and absolute discretion of MLN.
- 5. Time shall be of the essence in this agreement and regarding these rules and regulations.
- 6. Members may not transfer or sale or assign in any fashion the Membership without prior written approval from MLN
- 7. Forbearance or indulgence by MLN in enforcing any of the terms of this agreement and these rules or regulations shall not constitute a waiver of the obligations to be performed by the Member under this agreement and MLN shall be entitled to any remedy available to it pursuant this agreement or by law notwithstanding any such forbearance or indulgence.
- 8. This agreement will be construed or enforced in accordance with the laws of the United States of America.
- 9. Each and every term and provision contained in this agreement and in the rules and regulations is severable and if any such term or provision should be judged invalid, illegal or unenforceable, it shall not affect the validity, legality or enforceability of the remainder of the agreement or the rules and regulations or of any term or provision of the agreement or the rules and regulations and the remainder shall remain valid, legal and enforceable and in full force and effect.
- 10. Member agrees to provide written notice to MLN at least 30 days prior to the anniversary date of the Member agreement if the Member does not intend to renew the agreement. Unless such notice is received, this agreement shall be automatically renewed annually and the renewal fee and any other applicable charge will be charged to the Members credit card that MLN has on account.

## Membership

- 1. Each Member of a MLN Hub will be the sole representative of a given profession.
- 2. Each Member must be engaged in that profession as their main business and hold a current business license.

- 3. All Members of the group must be of good moral character and must follow the written Rules and Bylaws of the group.
- 4. No Member of the group will act in any manner which undermines or conflicts with the profession of another Member.
- 5. No Member shall be a Member of any other referral group of this kind

#### Dues:

- 1. Annual Membership is \$400
- 2. Quarterly Membership in \$125
- 3. Dues are non-refundable.
- 4. Dues are non-transferable
- 5. MLN reserves the right to increase fees at our discretion.

### Affiliate Marketing Program

- 1. Members understand that they must opt into the affiliate program to qualify for payment.
- 2. Member must notify MLN in writing if Member wishes to withdraw from the affiliate program.
- 3. MLN will pay all affiliate fees within 90 days of receipt of payment to MLN
- 4. Members agree that the first affiliate enrolled in the affiliate software tracking will be assigned to that Member account.
- 5. Member agrees that MLN is the final word for all affiliate disagreements

# Payment Structure for Affiliate Acquisitions

The Member agrees to the following payment terms for affiliate acquisitions:

## 1. Direct Affiliates:

- Member will receive 20% of the gross proceeds for each fully paying direct affiliate that joins MLN.
- Member will receive this compensation annually upon affiliates renewal

### 2. Second-Tier Affiliates:

- MLN will receive 10% of the net proceeds for each fully paying second-tier affiliate that joins MLN.
- Member will receive this compensation annually upon affiliates renewal

## 3. Third-Tier Affiliates:

- MLN will receive 5% of the net proceeds for each fully paying third-tier affiliate that joins MLN.
- Member will receive this compensation annually upon affiliates renewal

#### Attendance

- 1. Members are allowed a maximum of four absences from weekly meetings and quarterly mixers within any six-month period.
- 2. Members may not miss more than three consecutive meetings.
- 3. If a Member is unable to attend a meeting, they may send a substitute who is not currently a Member of the group. Members who send a substitute will not be marked as absent.
- 4. Members are expected to arrive on time.
- 5. Members are responsible for staying informed about the schedule for meetings and quarterly mixers, including any changes due to unforeseen circumstances.

### Practices and Standards

- 1. Members are expected to maintain a social media presence.
- 2. Members are expected to promote MLN and their Hubs on social media
- 3. Members are expected to help promote MLN and Hub events
- 4. Members are expected to help grow MLN and their Hubs
- 5. Members are expected to attend community networking events outside of their MLN responsibilities
